MEMORANDUM FOR SEE DISTRIBUTION

Subject: General Public Hunting Event on Camp Roberts 21-23 December 2014

- 1. Eligible Personnel:** Camp Roberts is open to the general public for hunting of approved game as defined in current year's State of California Hunting Regulations for only Coyote, Pig, Duck, Quail, & Rabbit from 21-23 December 2014. Fishing is closed during this hunting event.
- 2. Registration:** Any person hunting or fishing on Camp Roberts is required to have the appropriate hunting and/or fishing license, tags from the State of California and a Camp Roberts Hunting/Fishing Permit. Individuals needing a Camp Roberts permit must register in person at the Morale, Welfare, and Recreation Phoenix Recreation Center, BLDG 6083 (MWR). The MWR is open for registration on **8-11 December 2014** from 12 pm until 6 pm (1200-1800) and **12 December 2014** from 8 am until 12 pm (0800-1200). Registration requires permit applicants to fill out registration forms, attend required range, environmental, and safety briefings, and pay associated fees. A Camp Roberts Annual Hunting/Fishing Permit is \$100.00 and is valid for 365 days from date of purchase. The fee is paid by check, cash, or money order made payable to Camp Roberts MWR.
- 3. Time and Location:** All participants are required to check in and out of Gate 1 (Main Gate); the only gate authorized on this hunting day. Access to hunting areas begins at 0500 with check-out no later than one hour after the end of legal hunting time. You must have a valid U.S. Government/State issued Identification Card, Camp Roberts Annual Hunting/Fishing Permit, proof of eligibility status, current State of California Hunting License, and current year tag for the species you are hunting, on your person at all times.
- 4. Game:** Participants may pursue and take approved game as defined in current year's State of California Hunting Regulations for only Coyote, Pig, Duck, Quail, & Rabbit.
- 5. Safety and Environmental:** Upon arrival, every hunter is provided with a daily map of open hunting areas, take information forms, and other administrative information. Only non-lead ammunition is authorized for hunting on Camp Roberts. All weapons brought onto Camp Roberts must be transported and stored in accordance with



California State Law. All participants are reminded to pick up their expended shell casings and trash during this event.

6. **Legal:** California Fish and Wildlife Enforcement Officers are actively involved with the Camp Roberts Hunting and Fishing Program and have full access to the entire facility. Participants are required to comply with State of California hunting and fishing guidelines and regulations, and Camp Roberts' rules and policies while on Camp Roberts. Violations of any guidelines, regulations, rules, post procedures and/or policies may result in forfeiture of fees paid, a revocation of hunting privileges at Camp Roberts, and additional penalties under federal and state law.
