SUBJECT: Continuation of Location Selective Reenlistment Bonus (SRB) for Army National Guard (ARNG) Title 10 and Title 32 (T10/T32) Active Guard/Reserve (AGR) Soldiers

1. This message applies only to ARNG T10/T32 AGR Soldiers serving on Active Duty in Afghanistan, Iraq, and Kuwait only.

2. Effective January 1, 2007, this message authorizes ARNG T10/T32 AGR Soldiers qualified to reenlist Under Provisions (UP) NGR (AR) 600-200, Chapter 7 to receive a SRB UP 37 U.S.C., Sec 308. ARNG T10/T32 AGR Soldiers may reenlist/extend with a SRB IAW Implementation Policy in ALARACT message 006/2006, DTG 122304Z Jan 06, Subject: Implementation Guidance for Location Selective Reenlistment Bonus (SRB) for Army National Guard (ARNG) Active Guard Reserve (AGR) Soldiers and UP of Chief, Personnel Programs, Manpower and Resources Division Memo: Subject: Implementation Guidance for Location Selective Reenlistment Bonus (SRB) for Army National Guard (ARNG) Active Guard/Reserve (AGR) Soldiers, dated 24 January 2006.

SUBJECT: Continuation of Location Selective Reenlistment Bonus (SRB) for Army National Guard (ARNG) Title 10 and Title 32 (T10/T32) Active Guard/Reserve (AGR) Soldiers

3. UP 37 U.S.C. 308 ARNG AGR Soldiers voluntarily reenlisting or extending while in Afghanistan, Iraq, or Kuwait in support of Operation Enduring Freedom or Operation Iraqi Freedom are not required to satisfy the designated skill or unit requirement required under 37 U.S.C. 308 (a)(1)(b).
4. Retention NCOs must provide copy of reenlistment/extension contract to the appropriate personnel for the purpose of processing bonus payment.
5.
