Family Relief Fund

The California Military Family Relief Fund (CMFRF) was enacted by a Senate Bill to allow individual taxpayers to contribute through a selection on their state tax forms or by individual donations to CNG Families in need.

The California Military Family Relief Fund provides financial assistance, in the form of a one time grant, to service members and their dependents when there is a valid need. This fund is open to California National Guard members who meet the following eligibility criteria:

- Current member of the CNG or Reserve member of the Armed Forces of the United States in good standing
- Current California resident
- Deployment to active duty for at least 60 consecutive days in Title 10 USC status
- Member's military salary has decreased by 10%, or household income of member's family has decreased by at least 10% from income prior to deployment
- The member, within six months of returning from active duty, has experienced a 10% loss or greater, in income compared to pre-deployment income, as a direct result of deployment
- The member was injured while serving on active duty and is actively seeking assistance through the United States Department of Veterans Affairs with regard to disability compensation benefits or treatment, or both benefits or treatment, or both.

Families requiring financial assistance may contact their unit or a CMFRF representative at J1@ca.ngb.army.mil to apply for financial assistance grants.

- Help purchase, rent or lease a vehicle
